Discussion took place on 'safer travel environment' in relation to Hunter's Lodge junction, routes through the village and the use of Trinity Hill (for traffic going into Lyme Regis).

6. Finance – all accounting has been completed and £700 was returned. Discussion took place on future funding applications – should this prove necessary to cover costs of producing the final document for parishioners to read and vote upon.
7. Locality – Jo Widdicombe has suggested that we meet. It was agreed that we would decide the purpose of a meeting at our next meeting which would take place in a fortnight's time. After which John G would contact her.
8. Simon Williams had provided notes to assist the group in the next stage of preparations for the NP itself. Group members were asked to read his paper and be ready to comment at the next meeting.
